25 The Court has considered the Motion for Order in Aid of Receivership (the
26 "Motion") of Krista Freitag ("Receiver"), the Court-appointed permanent receiver
27 for Defendants World Capital Market Inc., WCM777 Inc., and WCM777 Ltd. d/b/a
28 WCM777 Enterprises, Inc., Relief Defendants Kingdom Capital Market, LLC;

1 Manna Holding Group, LLC; Manna Source International, Inc.;

2 WCM Resources, Inc.; and their subsidiaries and affiliates (collectively,

3 "Receivership Entities"), and all papers in support of and in opposition thereto.

4 Finding good cause, the Court GRANTS the Motion in its entirety and ORDERS as

5 follows:

6 1. The Receiver is authorized to employ Allen Matkins Leck Gamble

7 Mallory & Natsis LLP ("Allen Matkins") as her legal counsel.

8 2. The Receiver is relieved from the requirements in Local Rule 66-5 and

9 Local Rule 66-7 to file a schedule of known creditors and to mail notices of all

10 known creditors.

11 3. The Receiver is authorized to (a) close frozen bank accounts of the

12 Receivership Entities and have the balances wired to receivership bank accounts;

13 and (b) add her partner, Thomas C. Hebrank of E3 Realty Advisors, Inc. as an

14 additional authorized signatory for receivership accounts.

15 4. The Receiver is authorized to list the single-family residential

16 properties located at 16114 Grand Ave., Lake Elsinore, CA; 307 Elfwood Dr.,

17 Monrovia, CA; and 710 Arabian Lane, Walnut, CA (the "Residential Properties"),

18 with licensed brokers for sale.

19 5. The Receiver's proposal to file, on a quarterly basis, interim reports and

20 interim fee applications for herself and Allen Matkins is approved.


