

ENGAGEMENT OF MANAGEMENT
COMPANY AND CONSULTANT FOR
GOLF COURSES

1 The Court has considered the *Ex Parte* Application of Krista Freitag
2 ("Receiver"), the Court-appointed permanent receiver for Defendants World Capital
3 Market Inc., WCM777 Inc., and WCM777 Ltd. d/b/a WCM777 Enterprises, Inc.,
4 Relief Defendants Kingdom Capital Market, LLC; Manna Holding Group, LLC;
5 Manna Source International, Inc.; WCM Resources, Inc.; and their subsidiaries and
6 affiliates (collectively, "Receivership Entities") for an Order Authorizing
7 Engagement of Management Company and Consultant for Golf Courses ("*Ex Parte*
8 Application"), and all papers in support of and in opposition thereto. Finding good
9 cause, the Court orders as follows:

- 10 1. The *Ex Parte* Application is granted;.
- 11 2. The Receiver is authorized to engage a management company and
12 consultant for the following golf course properties of the receivership estate:
 - 13 • the Glen Ivy Golf Club located in Corona, California; and
 - 14 • the Links at Summerly located in Lake Elsinore, California.
- 15 3. The Receiver is further authorized to pay such management company
16 and consultant on a monthly as-invoiced basis for services provided in an amount
17 not to exceed \$20,000 per month.
