10 on for hearing on July 13, 2015. Appearances were as noted on the record.


11 The Court having received and read the Application, including any supporting
12 declarations and objections filed therein, and being so advised in the matter and
13 finding good cause, orders as follows:

14 **IT IS ORDERED** that the Application of Allen Matkins is granted.

15 **IT IS FURTHER ORDERED** that Allen Matkins' fees and costs for the
16 Third Interim Period are allowed and approved, on an interim basis, in the amounts
17 of \$153,144.00 and \$9,707.87, respectively.

18 **IT IS FURTHER ORDERED** that the Receiver is authorized and directed to
19 pay Allen Matkins \$122,515.00 in fees and \$9,707.87 in costs from assets of the
20 receivership estate, which amounts reflect an interim payment of 80% of the
21 allowed fees and 100% of the allowed costs.
