

1 The Court, having considered the motion of Krista L. Freitag ("Receiver"),  
2 Court-appointed permanent receiver for Defendants World Capital Market Inc.;  
3 WCM777 Inc.; WCM777 Ltd. d/b/a WCM777 Enterprises, Inc.; and Relief  
4 Defendants Kingdom Capital Market, LLC; Manna Holding Group, LLC; Manna  
5 Source International, Inc.; WCM Resources, Inc.; ToPacific Inc.; To Pacific Inc.;  
6 and their subsidiaries and affiliates ("Receivership Entities"), for an order  
7 (A) Sustaining Omnibus and Specific Objections to Claims; (B) Approving  
8 Proposed Allowed Amounts of Claims; and (C) Approving Distribution Plan and  
9 Authorizing Receiver to Make Interim Distributions ("Motion"), and good cause  
10 appearing therefor, hereby orders as follows:

- 11 1. The Motion is granted;
- 12 2. The Receiver's omnibus and specific objections to claims as discussed  
13 in the Motion are sustained;
- 14 3. The Receiver's proposed allowed amounts of investor claims as  
15 reflected on Exhibits A through C to the Supplemental Declaration of Krista L.  
16 Freitag in Support of the Motion are approved;
- 17 4. The Receiver's proposed allowed amounts of trade creditor and  
18 personnel claims as reflected on Exhibit D to the Declaration of Krista L. Freitag in  
19 Support of the Motion are approved;
- 20 5. The Distribution Plan attached as Exhibit E to the Declaration of  
21 Krista L. Freitag in Support of the Motion is approved; and
- 22 6. The Receiver is authorized to make interim distributions to the holders  
23 of allowed claims in the total amount of \$21 million.
