1 The Fee Application of Allen Matkins Leck Gamble Mallory & Natsis LLP,
2 General Counsel to the Receiver for Payment of Fees and Reimbursement of
3 Expenses ("Application") filed by Allen Matkins Leck Gamble Mallory &
4 Natsis LLP ("Allen Matkins"), general counsel to Krista L. Freitag ("Receiver"),
5 Court-appointed permanent receiver for Defendants World Capital Market Inc.;
6 WCM777 Inc.; WCM777 Ltd. d/b/a WCM777 Enterprises, Inc.; and Relief
7 Defendants Kingdom Capital Market, LLC; Manna Holding Group, LLC; Manna
8 Source International, Inc.; WCM Resources, Inc.; ToPacific Inc.; To Pacific Inc.;
9 and their subsidiaries and affiliates ("Receivership Entities"), came on for hearing
10 on October 1, 2018. Appearances were as noted on the record.

11 The Court having received and read the Application, including any
12 supporting declarations and objections filed therein, and being so advised in the
13 matter and finding good cause, orders as follows:

14 **IT IS ORDERED** that the Application of Allen Matkins is approved.

15 **IT IS FURTHER ORDERED** that Allen Matkins' fees and costs for the
16 October 1, 2017 through June 30, 2018 period are allowed and approved on a final
17 basis in the amounts of \$27,453.60 and \$91.33, respectively.

18 **IT IS FURTHER ORDERED** that the \$1,590,926.58 (\$1,491,280.76 in
19 fees and \$99,645.82 in costs) approved for payment to Allen Matkins on an interim
20 basis pursuant to the firm's previously-approved thirteen interim fee applications is
21 approved on a final basis.


22 **IT IS FURTHER ORDERED** that the fees held back from Allen Matkins'
23 13 interim fee applications, which total \$372,820.19, are approved on a final basis.

24 **IT IS FURTHER ORDERED** that based upon the foregoing approved
25 amounts, the Receiver is authorized to pay Allen Matkins \$400,365.12 from assets
26 of the receivership estate for fees and costs incurred through June 30, 2018.

1 **IT IS FURTHER ORDERED** that the Receiver is authorized to pay Allen
2 Matkins' actual fees and costs up to \$30,000 for legal work from July 1, 2018 on in
3 order to compensate Allen Matkins for work required to conclude the receivership.
