1 The Fee Application of Krista L. Freitag ("Receiver"), Court-Appointed
2 Receiver, for Payment of Fees and Reimbursement of Expenses ("Application"),
3 Court-appointed permanent receiver for Defendants World Capital Market Inc.;
4 WCM777 Inc.; WCM777 Ltd. d/b/a WCM777 Enterprises, Inc.; and Relief
5 Defendants Kingdom Capital Market, LLC; Manna Holding Group, LLC; Manna
6 Source International, Inc.; WCM Resources, Inc.; ToPacific Inc.; To Pacific Inc.; and
7 their subsidiaries and affiliates ("Receivership Entities"), came on for hearing on
8 October 1, 2018. Appearances were as noted on the record.

9 The Court having received and read the Application, including any supporting
10 declarations and objections filed therein, and being so advised in the matter and
11 finding good cause, orders as follows:

12 **IT IS ORDERED** that the Application is approved.

13 **IT IS FURTHER ORDERED** that the Receiver's fees and costs for the
14 October 1, 2017 through June 30, 2018 period are allowed and approved, on a final
15 basis, in the amounts of \$64,910.70 and \$2,121.06, respectively.

16 **IT IS FURTHER ORDERED** that the \$1,724,891.70 (\$1,609,302.18 in fees
17 and \$115,589.52 in costs) approved for payment to the Receiver on an interim basis
18 pursuant to her previously-approved thirteen interim fee applications is approved on
19 a final basis.

20 **IT IS FURTHER ORDERED** that the fees held back from the Receiver's
21 13 interim fee applications, which total \$402,325.55, are approved on a final basis.

22 **IT IS FURTHER ORDERED** that based upon the foregoing approved
23 amounts, the Receiver is authorized to pay herself \$469,357.31 from assets of the
24 receivership estate for fees and costs incurred through June 30, 2018.


