7 The Court, having considered the Fee Application, the supporting

8 declarations, objections and the Supplemental Declaration of David Zaro in which

9 Allen Matkins adjusted its fees and costs consistent with this Court's rulings, filed

10 therein, and being so advised in the matter and finding good cause, orders as

11 follows:

12 **IT IS ORDERED** that the Fee Application of Allen Matkins is granted.

13 **IT IS FURTHER ORDERED** that Allen Matkins' fees and costs for the First

14 Interim Period are allowed and approved, on an interim basis, in the amounts of

15 \$435,993.80 and \$29,761.47, respectively.

16 **IT IS FURTHER ORDERED** that the Receiver is authorized and directed to


17 pay Allen Matkins \$348,795.40 in fees and \$29,761.47 in costs from assets of the

18 receivership estate, which amounts reflect an interim payment of 80% of the

19 allowed fees and 100% of the allowed costs.
