27 Expenses (the "Fee Application") filed by Krista L. Freitag ("Receiver"), Court-
28 appointed permanent receiver for Defendants World Capital Market Inc.; WCM777

1 Inc.; WCM777 Ltd. d/b/a WCM777 Enterprises, Inc.; and Relief Defendants
2 Kingdom Capital Market, LLC; Manna Holding Group, LLC; Manna Source

4 subsidiaries and affiliates (the "Receivership Entities"), came on for hearing on
5 November 10, 2014. Appearances were as noted on the record.


6 The Court, having considered the Fee Application, the supporting
7 declarations, objections and the Supplemental Declaration of Krista L. Freitag in
8 which the Receiver adjusted her fees and costs consistent with the Court's ruling,
9 and being so advised in the matter and finding good cause, orders as follows:

10 **IT IS ORDERED** that the Fee Application of the Receiver is granted.

11 **IT IS FURTHER ORDERED** that the Receiver's fees and costs for the First
12 Interim Period are allowed and approved, on an interim basis, in the amounts of
13 \$210,449.70 and \$35,150.56, respectively.

14 **IT IS FURTHER ORDERED** that the Receiver is authorized and directed to
15 pay herself \$168,359.76 in fees and \$35,150.56 in costs from assets of the
16 receivership estate, which amounts reflect an interim payment of 80% of the
17 allowed fees and 100% of the allowed costs.
